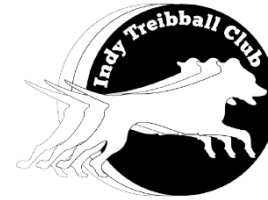

The running orders within each level will be adjusted to give competitors with multiple dogs or runs the most opportunity for breaks between runs.

## Trial Site

**Equipment** will conform to current NATE Regulations.

**Time** will be taken manually.

**Warm up area:** Appropriate size ball will be located in designated area.

**Ring Familiarization:** Each handler will be allowed to walk their dog around the ring prior to the start of the trial at 8:00am.

No grooming is allowed in the building.

## Eligible Dogs

This trial is open to all dogs twelve (12) months of age or older. Exceptions are females in season, aggressive dogs, and dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. Withdrawal for females in season must provide notice before the official start of the trial, and a refund will be given.

## Height Divisions

Ball Size	Dog Height
Mini	dogs 9" and under at the withers
X-Small	dogs over 9" up to 14" at the withers
Small	dogs over 14" up to 18" at the withers
Medium	dogs over 18 up to 22" at the withers
Large	dogs over 22" up to 26" at the withers
X-Large	dogs over 26" at the withers

All dogs which have not participated in ITC trials will be height checked with wickets. Measurements will be done beginning at 7:30 and complete prior to the 8:00 start time.

**Please note:** Exhibitors are responsible for complete, accurate, and legible information on their entry forms. Illegible or incomplete entries cannot be entered into the show. All entries must be made on Entry Form provided and must include the Agreement and Rules. No entry shall be accepted which specifies any condition as to its acceptance.

## Awards

- Ribbons will be awarded for qualifying scores.
- Ribbons will be awarded for 1<sup>st</sup> thru 4<sup>th</sup> place.

## Notice to the Exhibitors

- Cash or checks will be accepted as payment for the trial. Checks should be made payable to ITC. Returned checks will not constitute valid entry. The Trial Secretary will add a \$20 collection fee to the amount of each returned check. Checks will be cashed after closing date.
- Day of show entries at the same rate per run (\$15) will be accepted for additional runs. Entries must be received no later than 7:30am.
- If a handler's dog damages a ball, the handler must pay a standard replacement fee for that ball by the end of the trial or forfeit qualifying runs and future trial entries by suspension.
- The safety of the dogs is our primary concern. By entering this trial exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all behaviors safely.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and children. Any exhibitor whose dogs or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may be asked to leave the show site by the Trial Committee. In such case, no refund of any fees will be made. Minor children must be supervised at all times. Failure to do so may result in being asked to leave the show site by the Trial Committee.
- Pinch collars, electric and dummy electric collars, choke and special training collars are prohibited on the Trial grounds. This includes bark collars. Head halters and no-pull harnesses are permitted on trial grounds but not in the warm-up, on-deck, or game field areas.
- Exhibitors may wear shirts or insignia of their training group if they wish.
- All dogs must be on leash at all times except when in the ring or designated warm-up area. Judges are not required to wait for dogs. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged.
- Exhibitors are responsible for cleaning up after their own dogs. Please help us keep this site clean future use. Hotels/motels are considered to be part of the show environs.
- **AVMA Statement:** Exhibitors should follow their veterinarians' recommendations to assure their dogs have appropriate vaccinations and are free of internal and external parasites and communicable diseases.
