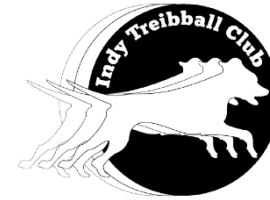

Trial Site

Equipment will conform to current NATE Regulations.

Time will be taken manually.

Warm up area: Appropriate size ball will be in the designated area.

Ring Familiarization: Each handler will be allowed to choose if they would like to once walk their dog around the perimeter of the ring; or push a single ball from their point ball distance to the goal before the start of the trial at 8am.

No grooming is allowed in the building.

Eligible Dogs

This trial is open to all NATE registered dogs twelve (12) months of age or older. NATE registration can be done online at www.nationaltreibball.com. Exceptions are females in season, aggressive dogs, and dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. Withdrawal for females in season must provide notice before the official start of the trial, and a refund will be given.

Height Class

Ball Size	Dog Height
Mini	dogs 9" and under at the withers
X-Small	dogs over 9" up to 14" at the withers
Small	dogs over 14" up to 18" at the withers
Medium	dogs over 18 up to 22" at the withers
Large	dogs over 22" up to 26" at the withers
X-Large	dogs over 26" at the withers

All dogs which have not participated in Indy Treibball Club trials will be height checked with wickets. Measurements will be done beginning at 7:30 and complete prior to the 8:00 start time.

Divisions

The A division is for dogs who have not earned a title at that level.

The B division is for dogs that have earned a Treibball Enthusiast title and are continuing to compete towards the Outstanding Treibball Enthusiast title in that level.

The Veteran divisions are for dogs 8 years and older.

Please note: Exhibitors are responsible for complete, accurate, and legible information on their entry forms. Illegible or incomplete entries cannot be entered into the show. All entries must be made on Entry Form provided and must include the Agreement and Rules. No entry shall be accepted which specifies any condition as to its acceptance.

Awards

- Ribbons will be awarded for 1st thru 4th place.

Notice to the Exhibitors

- Cash or checks will be accepted as payment for entries. Checks should be made payable to ITC. Returned checks will not constitute valid entry. The Trial Secretary will add a \$20 collection fee to the amount of each returned check. Checks will be cashed after the closing date.
- Day of show entries at the same rate per run (\$15) will be accepted for additional runs. Entries must be received no later than 7:30am, day of show.
- If a handler's dog damages a ball, the handler must pay a standard replacement fee for that ball by the end of the trial or forfeit qualifying runs and future trial/match entries by suspension.
- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all behaviors safely.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and children. Any exhibitor whose dogs or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive

behavior may be asked to leave the show site by the Trial Committee. In such case, no refund of any fees will be made. Minor children must be supervised at all times. Failure to do so may result in being asked to leave the show site by the Trial Committee.

- Pinch collars, electric and dummy electric collars, choke, and special training collars are prohibited on the Trial grounds. This includes bark collars. Head halters and no-pull harnesses are permitted on trial grounds but not in the warm-up, on-deck, or game field areas.
- Exhibitors may wear shirts or insignia of their training group if they wish.
- All dogs must be on leash at all times except when in the ring or designated warm-up area. Judges are not required to wait for dogs. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged.
- Exhibitors are responsible for cleaning up after their own dogs. Please help us keep this site clean future use. Hotels/motels are considered to be part of the show environs.
- **AVMA Statement:** Exhibitors should follow their veterinarians' recommendations to assure their dogs have appropriate vaccinations and are free of internal and external parasites and communicable diseases.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lesser of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person.
